A Practical Approach to Teaching English at Gymnasium (Proseminar)

In this workshop I would like to provide you with tools that enable you to become a competent, confident and creative teacher. My hands-on approach will combine the theory of didactics with practical suggestions for teaching grammar and vocabulary, and getting learners to talk and write. Beyond that, you will be introduced to ways of building rapport and maintaining a work-life balance inside and outside of the classroom.

Designing and Marking Tests (Proseminar)

Testing is probably one of the activities that most expose the professional attitude and suitability for the job of any foreign language teacher. Not only is the teacher obliged to show his own foreign language proficiency – teachers also have to show their ability - and willingness - to present pupils with fair and valid tests on the contents taught beforehand. In this seminar we will explore how parameters such as validity, objectivity, reliability, transparency or just a neat external form determine a decent and acceptable test for foreign language learners at all levels. Moreover, different test formats and exercises will be examined for their practical value and for the application of the above parameters. Lastly, students will be given the opportunity to develop small tests, test exercises or lessons of their own - just as they will be shown examples taken from the lecturer's daily school practice. The latter will also include some concrete practice in terms of marking a test.

Developing Intercultural Competence in English Classroom (Proseminar)

This course is concerned with the evaluation of the teaching materials in terms of developing intercultural competence in English language classrooms. After providing background on the importance of intercultural competence and introducing different methods/tools which can be used in developing this kind of competence, some teaching materials will be evaluated. The aim of this evaluation is to find the extent to which these teaching materials consider the cultural diversity and develop intercultural competence as one of the most important skills in learning a foreign language.

Games and Plays in the EFL Classroom (Proseminar)

“Can we play a game?” Games and plays are not only fun, but they are also great tools for language learning. When purposefully designed and effectively integrated into the foreign language classroom, they, for example, may improve pupils' vocabulary and grammar. In addition, they can foster different skills and competences such as listening, speaking, reading, writing and ICC. This course intends to give an overview of play activities which can be integrated into the EFL classroom to promote different communicative competences. Various types of games and plays will be looked at (e.g. board games, movement games, games with music, TV show games, digital games and role-plays). Special focus will be put on how to make use of those games and plays in a concrete classroom situation. This will, of course, also require some playing on your part!

Methods of Teaching English in Elementary School (Proseminar)

Learning English at elementary school should be a unit of “head, heart and hand”. This means cognitive, emotional and practical skills should be stimulated and used during the lesson in various activities. How can teachers have pupils listen to and talk in the foreign language with all their senses and without any shyness. Many concepts and various different approaches were discussed since the beginning of teaching English to younger learners. This seminar should introduce typical methods and techniques of teaching a foreign language in elementary school. Together we will develop an ABC with necessary methods and techniques for the elementary school.

Teaching Cultural Studies: USA (Proseminar)

The cultural component of foreign language acquisition has received greater emphasis again since the end-1990s – not only in schools, but also in adult education. The acquisition of a practical understanding of the target culture and society, including a knowledge of relevant historical, geographical and political issues, has thus become an important element in teacher training programs. This Proseminar offers an in-depth insight into the USA and how to teach cultural studies in the classroom.

Teaching Reading: from Textbook to Literature (Proseminar)

This seminar is aiming at a deeper understanding of the concept of “text” and how to develop the necessary skills to grapple with the latter. From closed guidance in the phase of language acquisition to competent and independent use of any literary text – thus the progression would run if shortly put. How to organise this will be the focus of this seminar. Procedural knowledge such as reading strategies just as much as declarative knowledge and positive attitudes are to be acquired by learners – a demanding task that needs to be thought through and well organised. Lastly, students should have a go at teaching relevant parts of this process by preparing a short lesson project, which will ultimately be the basis of their short term paper.

Lernziele/Kompetenzen: <u>Fachlich:</u> Die Studierenden verfügen über vertiefte Kenntnisse in einem Spezialgebiet der Englischdidaktik. Zugeordnete Lehrveranstaltungen: Classroom Fictions and Realities (Hauptseminar) John Keating (Robin Williams) in Dead Poets Society (1989), LouAnne Johnson (Michelle Pfeiffer) in Dangerous Minds (1995) or Miss Moore in Toni Cade Bambara's "The Lesson" (1972) – these are just three examples out of many which have one thing in common: they represent 'teacher characters' in fictional texts which, in turn, can be		

referred to as 'classroom fictions'. A considerable number of texts – including genres such as movies, TV series, sitcoms, novels, short stories, poems, or pop songs – is dedicated to the portrayal of teachers, their students, and classroom scenarios. In this course we will take a closer look at selected examples of such 'classrooms fictions', and we will approach them in three different ways: (1) Focus on text: We will interpret and discuss these 'classrooms fictions' using those categories, concepts, and tools which are essential for the analysis of fictional texts (e.g. characters, plot, setting, motifs, themes, structure, form etc.). Teaching House of Cards in the Upper Secondary Level (Hauptseminar)

Audio-visual media still lead a Cinderella existence when it comes to teaching English as a foreign language. Nevertheless, films and series are very popular with pupils and a lot of competences can be promoted – teachers just need to make sure that films are not consumed passively. In this class, we will draw our attention to film-based language learning (FBLL) in the upper secondary level. We will have a closer look at short (music videos), medium (series) and long formats and possible modes of presentation. The foundation of FBLL in curricula, educational standards and CEFR will also play an important role. Finally, the American drama series House of Cards will serve to illustrate how much students can benefit from FBLL.

Training and Assessing Communicative Skills (Hauptseminar)

In Bavarian classrooms, the four/five communicative skills as inscribed in the CEFR have been trained and developed quite explicitly for over a decade now. They were already well-reflected within the current curricula and will also feature prominently in LEHRPLAN+. Bearing this in mind, we shall examine how the development of these latter skills within a learner's career has been put into practice, how we can stimulate and foster progress for any of these - and also how reading, listening, speaking and written production should be assessed at school. Lastly, this seminar wishes to elucidate what role "means of speech" – in particular grammatical phenomena – play when it comes to communicating in a secondary language, especially in a classroom setting.

'The Way Teachers Talk': Developing Classroom Discourse Competence (Hauptseminar)

Research has shown that the way EFL teachers talk to and with their students in class has an impact on learners' language acquisition process and learning outcome. Using this correlation as a general starting point in this course, we will explore, discuss, analyze, and reflect upon various ways of optimizing classroom communication and making teacher talk more effective for the benefit of L2 learners. Course participants will gain a deeper understanding of the relationship between lesson content, teacher talk, classroom interaction, and foreign language learning. They will also acquire the tools which enable them to analyze and reflect on processes of spoken classroom discourse. Among other things, we will focus on selected aspects of classroom discourse to explore in which ways teacher talk can either promote or hinder classroom interaction and language learning. We will, for instance, consider the following questions: What kinds of questions do teachers ask? And how effective are the

Examenskolloquium LA Gym (II) (Kolloquium)

Die grundlegenden Fachbereiche der Englischdidaktik werden anhand der 4 großen Themenschwerpunkte („Körbe“) für die Staatsexamensprüfung aufgearbeitet (LPO I 2008): a) Vertrautheit mit Sprachlerntheorien und den individuellen Voraussetzungen des Spracherwerbs b) Kenntnis der Theorie und der Methodik des kommunikativen Englischunterrichts c) Vertrautheit mit den Theorien und Zielen des interkulturellen Lernens und deren Umsetzung im Unterricht d) Überblick über Ziele und Verfahren der Textarbeit im Hinblick auf interkulturelle, literarische und sprachliche Bildungsziele. Starting out with a look at Pre-Columbian civilizations, we will then work our way from the colonial period to the revolutionary era and on into the 19th century. However, our focus will be on themes, discourses, and concepts rather than chronologies. Topics discussed will cover American identity constructions and value systems, ideas of God and nature, struggles over racism and slavery, the beginnings of the women's rights movement, experiments in alternative living, and developments in art and literature. Course requirements include a willingness to participate in classroom discussions and activities, as well as the punctual completion of both reading and writing assignments.
American Life Writing (Vorlesung) Life writing, autobiography in particular, tends to focus on the life of one person, the autobiographer. However, as critics have highlighted in the past two decades, autobiographical texts do not only narrate and individual identity, but they tell stories of relationality: the individual's relation to other people (such as family) and to groups and collectives (such as an ethnic group or the nation). Such relationality plays a crucial role for narrative self-construction. This lecture course looks at the range of American life writing from the 1790s to the present proliferation of life writing and the various ways in which autobiographical texts present and explore subject constitution as relational. Specific topics include but are not limited to immigrant autobiography; slave narratives; Native American life writing; collaborative life writing; illness narratives; filial memoirs; politicians' and celebrities' life writing; blogs and social media. ... As environmental problems result from interacting natural and cultural processes, dealing with those problems requires both scientific and humanistic knowledge and, beyond that, integrative thinking across and outside disciplinary and epistemological boundaries. This kind of thinking is precisely what the emerging field of the Environmental Humanities attempts to promote. Lexicology (Seminar) This course serves as an introduction to the study of lexis, i.e. the stock of words in a given language (in our case of course English). The class will thus deal with the structural (i.e. morphological) and semantic properties of English words, as well as their origins and distribution. We will also look at how the English vocabulary can be structured according to specific parameters and how this may be realized in dictionaries.		
Morphology (Seminar) This seminar deals with issues of advanced morphological theory. Lexical Morphology, for example, considers the word, not the morpheme to be the central unit of analysis and represents the lexicon as a hierarchical structure that allows for the interaction of morphological and phonological processes. We will also have a look at Prosodic Morphology to account for languages with non-concatenative morphological structure. Other morphological elements examined in more detail will be clitics and compounds.		
Topics in Construction Grammar (Seminar) Constructionist approaches to grammar have expanded the Saussurean notion of the linguistic sign as a conventionalised pairing of meaning and form to apply to all levels of grammatical description. A speaker's knowledge of a language is accordingly viewed as comprised of her knowledge about a network of constructions, i.e. form-meaning pairings at varying levels of complexity and abstraction, such as the levels of words, idioms,		

or syntax. In this course, we will look into major approaches within CxG (e.g. Goldberg's Cognitive Construction Grammar, Fillmore & Kay's Berkeley Construction Grammar, Croft's Radical Construction Grammar, etc.) discuss aspects of their empirical findings, and apply some of their methodologies to English data. Over the course of the semester, this will give us the opportunity to explore the role of constructions in numerous fields of linguistics, including language processing, language acquisition, language variation and language change.

Topics in Functional Grammar (Seminar)

Unlike formal approaches to grammar, which consider grammar as a set of rules specifying all possible grammatical structures of a language, functional approaches to grammar are concerned with how language is used to achieve various purposes in different social contexts. This course will focus on one particular functional approach to grammar, i.e. Halliday's Systemic Functional Grammar (SFG), which sees language as a system that represents a resource for speakers to express particular functions in social interaction. The aim of this course is threefold: (1) to introduce students to the basic tenets and key concepts of SFG (e.g. nominal group, mood/modality, cohesion, theme/rheme, process/participant); (2) to give students the opportunity to practically apply these principles by analyzing sentences from different text types; (3) to compare the key topics underlying SFG with more traditional approaches to grammar, notably Quirk et al.'s Comprehensive Grammar of the English Language.

Key Topics in Pragmatics (Vorlesung)

The goal of this lecture course is to provide an introduction to the theory and practice of pragmatics, focusing in particular on pragmatics as a perspective, and applying and adapting the pragmatic perspective to the strategic use of language. We will discuss deixis, presupposition, speech act theory, Gricean pragmatics, Relevance Theory and implicature.

Articulatory Phonetics (Übung)

In this class you will be introduced to all the articulatory organs and processes involved in the production of speech starting from the brain "giving orders" to the muscles and including the lungs creating airflow, the larynx creating voice as well as the supraglottal articulators that create speech sounds that finally leave your lips as air pressure

fluctuations. The class will examine all the speech sounds possible in human languages, but of course there will be a special focus on the speech sounds of English and the characteristics best used to describe them.

Basic Phonetics A (Übung)

This class offers an introduction to the principles of Phonetics and Phonology, including the articulatory basis and feature descriptions of especially the phonemes and allophones that occur in the major varieties of English. There will be a practical focus on both British (RP) and American (GA) standard pronunciations as well on phonological transcriptions both using IPA (an account of the organizational principles of the IPA will be provided as well) and, for students of the "Lehramt", the systems expected in the Bavarian state exams.

Basic Phonetics B (Übung)

This class offers an introduction to the principles of Phonetics and Phonology, including the articulatory basis and feature descriptions of especially the phonemes and allophones that occur in the major varieties of English. There will be a practical focus on both British (RP) and American (GA) standard pronunciations as well on phonological transcriptions both using IPA (an account of the organizational principles of the IPA will be provided as well) and, for students of the "Lehramt", the systems expected in the Bavarian state exams.

Basics in Morphology and Word Formation (Übung)

In this course we will investigate in detail the internal structure of English words and the various processes that can be employed to enrich the lexicon by means of word-formation. After discussing the basic notions and key concepts in English morphology (e.g. word, word form, lexeme, morpheme etc.), we will take a closer look at various morphemic and non-morphemic word-formation patterns of present-day English (e.g. compounding, derivation, conversion, clipping etc.) from different perspectives. Whenever necessary, we will take a diachronic perspective and look, for instance, at the inflectional system or the productivity of certain word-formation patterns in different periods of English. There will be abundant opportunity to apply and practice morphological analyses in class.

Corpus Linguistics (Übung)

The ability to create, analyze and describe corpora is an absolute essential for proper linguistic research. In this course, you will acquire knowledge of the methodology of, and different approaches to, corpus analysis, learn how to use preexisting corpora, design and annotate your own and shape it for your intended research goals. To do that, we will cover a variety of tools and use them in a practical application approach, analyzing various linguistic features by gathering and processing data in a scientifically correct way, creating small corpora from different genres of discourse. While doing so, we will also look at challenges that arise when creating corpora, their qualitative and quantitative paradigms, statistical infrequencies and different plausibility functions as well as their implications on validity of data, and last but not least their use in fields such as language acquisition theory, diachronic linguistics and discourse analysis.

English as a Lingua Franca (Übung)

The English language can truly be called a "global language" as it is estimated that a quarter of the world's population is now able to communicate in English at a useful level. Furthermore, it is the most widely utilized language around the planet for international business, diplomacy, advanced education, law, the media, as well as for the dissemination of scientific and technological knowledge. A large proportion of those who use English are speakers of other languages, entailing a situation in which there are more non-native speakers than native speakers. As a result of this reality, in recent years a new approach to studying the use of English in international communication - English as a Lingua Franca (ELF) - has arisen. This course will explore issues related to ELF, including the features and characteristics of ELF use, the role of native speaker and standard language norms, language teaching and learning goals, linguistic stratification, and attitudes towards non-native speaker

Institutional Discourse (Übung)

In this course, we will investigate discourse in a variety of institutional contexts (e.g. schools, courtrooms, universities, cooperations, clinics, hospitals). We will build up a general (practical) knowledge of conversational analysis (transcription, pattern recognition, case analyses) in order to probe the language in/of institutions with a particular emphasis on ideology and practice, discourse organization, collective identity as well as persuasion

and manipulation. Case studies will include narratives in institutions; identity construction; 'talking an institution into being'; institutional gatekeeping encounters; front- and backstage in institutions; frame-shifting; facework and linguistic (im-)politeness; epistemic stance; language and power/agency and the interrelationships between professional and institutional discourses.

Modality (Übung)

How do we form and commit to predictions? How do we express the ability or necessity to do something? How do we know if an obligation is to be considered weak or strong? This course aims at providing answers to these questions (and more) by exploring form and function of modal expressions in different contexts: We will look at different sets of modals, quasi-modals and their adverb satellites and discuss their classification, strength, distribution as well as contextual use across various genres of spoken and written English. Whilst doing that, we will also examine differences and similarities of the various terminologies that are currently applied when modality is discussed and debate arising problems.

Quotations in Political Discourse (Übung)

Quotations are a ubiquitous meta-linguistic device; their communicative function consists in importing something said or written before into the discourse and assigning it the status of an object of talk. Through the act of quoting, the quoter expresses an evaluation of the source and/or content of the quotation, at the same time assigning the quotation the status of being relevant. The formatting of a quotation is chosen with regard to the contextual constraints and requirements of the discourse genre as well as to the quoter's communicative goal and intended perlocutionary effects. In this course, we are going to look at different forms of quotations and quotation markers, the functions of quoting, as well as various theoretical approaches to different aspects of quotation. We will focus on the strategic use of quotations in different types of mediated political discourse, such as interviews, parliamentary debates, commentaries, or editorials.

Syntactic Analysis (Übung)

This Übung provides a systematic and practically-oriented introduction to English syntax, the study of the internal structure of phrases, clauses and sentences. The aim of the course is to help students develop analytic skills to explore the patterns of English syntax, and learn precise ways of doing syntactic analysis for a variety of constructions. Based on Quirk et al.'s (1985) Comprehensive Grammar of the English Language (CGEL), we will discuss various central topics (e.g. parts of speech, phrase structure, syntactic functions, coordination, subordination, multi-word verbs etc.), which will then be taken as a springboard for practical exercises. Sentences taken from the state exam will serve as the textual basis for a broad range of in-depth, problem-oriented syntactic analyses.

The Phonology-Morphology Interface (Übung)

In this seminar we will - as the title indicates - look at the interaction between phonology and morphology, starting with simple phonologically conditioned allomorphy like, e.g., the behavior of plural-/S/ and continuing with more complex processes like e.g., the well-known Trisyllabic Laxing Rule, which accounts for vowel changes like the one between 'divine' and 'divinity'. This will be our starting point for investigating of Lexical Phonology and Morphology as well as the accompanying phenomena of Cyclicity or the Elsewhere Condition.

[S]uch narratives will crucially inform the ethos embodied in our responses to the risk, impact, and aftermath of eco-catastrophe – whether, for example, we adopt the bunker mentality that it's every man for himself; or whether we are prepared to lend a helping hand to total strangers, including those 'strange strangers' who are not of our kind." (Rigby) Living on a planet that experiences dire ecological disasters in an exceedingly accelerated frequency, the question remains what the role of the humanities in general and literary studies in particular can and needs to be within our global reality. Thus, in this seminar, we will examine basic c ... (weiter siehe Digicampus) Literary London (Proseminar) "[T]his great and monstrous thing, called London" (Daniel Defoe) has been a prominent topic in English literature since the Middle Ages. London texts range from seemingly realistic depictions of the British capital to metaphorically charged re-constructions of real-life London that aim at resistance towards existing discourses of power and from praises of the city constituting an epitome of civilisation and progress to its condemnation as

the centre of crime and horror. In this course we will take a look at the manifold ways in which the city of London has been translated into text and the modes of representation that this translation entails. Bound up with those modes of representation is a changing perception of the city that reflects the different ways of life in the metropolis throughout the centuries. We will trace the trajectory of this changing perception of the British capital in poems, short stories, and novels from the 18th century to the present and link it to questions of r

PS Film Analysis: Indigenous Film (Proseminar)

This course is an introduction to film analysis and will also provide an insight into discussions on indigeneity. We will learn about the basic concepts and keywords of film analysis and discuss the notions of indigeneity and memory/ (colonial) history from different perspectives. The focus lies mainly on indigenous films from Canada and Australia, but we will also have a look on the depiction of indigenous people in the western and in children's movies.

Shakespeare in Love (Proseminar)

"Not of an age, but for all time" – Ben Jonson's famous words of praise about his fellow playwright – aptly describe not only Shakespeare but also love as a literary and dramatic subject. Ever since there was literature, love has been a favourite topic of authors and audiences alike. Fascinatingly, despite each era's distinctive social, moral, and epistemological context and each generation's characteristic structure of feeling, the topic of love has up to the present day yielded similar stories grounded in similar conceptions of this fundamental human emotion. And yet, in order to make visible and recognise these familiar narratives we have to delve deep into the object of analysis and try both to understand it in its historical context and to extract the notions of love from their concrete literary manifestation. In this course, Shakespeare's plays will be the thing, wherein we'll catch the conscience of his time, but also the seemingly timeless narratives of love that permeate Weste

The Renaissance Poetic Imagination (Proseminar)

As elsewhere in Europe, the Renaissance period in England (roughly the 16th and early 17th centuries), its various technological advancements and social and political changes brought about the flourishing of the arts and literature to a hitherto unseen extent. It was a time of change and progress, the dawn of modernity (hence it is also called the Early Modern period), and it gave us some of the most famous poets of the English language. In this course we will look at the status of poetry and its functions in the English Renaissance, but also at how poetic language gains traction and how it may affect readers. How do the conceits (extended metaphors that structure the entire poem) that were popular at the time work to convey emotions and ideas? What is the effect of the use of highly unusual poetic images (e.g. fleabites for lovemaking or a compass needle for parting lovers) by the so-called 'metaphysical poets'? What status did poetry have in a world that valued the arts, but at the s

Writing and Reading the American Dream (Seminar)

Let America be America again. Let it be the dream it used to be. Let it be the pioneer on the plain Seeking a home where he himself is free. (Langston Hughes) The myth of the "American Dream" seems to be essential for the homo americanus. The promised land of America offered an optimistic idea of upward social mobility and the realization of individual dreams. In this seminar we will read examples of literary descriptions of this belief in seemingly possible personal fulfillments in the American society. The national ethos of the American Dream is based on descriptions in the Declaration of Independence where "all men are created equal" with the right to "life, liberty and the pursuit of happiness". We will follow characters who experience their personal pursuit of happiness or how the myth of this influences their personal failure. We will analyze how American authors contextualized this national myth in their works such as theater drama and other narratives. Apart from canonized work,

American Cultural History before the Civil War (Übung)

This course will offer an overview of key issues, trends, and events in early American cultural history. Starting out with a look at Pre-Columbian civilizations, we will then work our way from the colonial period to the revolutionary era and on into the 19th century. However, our focus will be on themes, discourses, and concepts rather than chronologies. Topics discussed will cover American identity constructions and value systems, ideas of God and nature, struggles over racism and slavery, the beginnings of the women's rights movement, experiments in alternative living, and developments in art and literature. Course requirements include a willingness to participate in classroom discussions and activities, as well as the punctual completion of both reading and writing assignments.

American Life Writing (Vorlesung)

Life writing, autobiography in particular, tends to focus on the life of one person, the autobiographer. However, as critics have highlighted in the past two decades, autobiographical texts do not only narrate and individual identity, but they tell stories of relationality: the individual's relation to other people (such as family) and to groups and collectives (such as an ethnic group or the nation). Such relationality plays a crucial role for narrative self-construction. This lecture course looks at the range of American life writing from the 1790s to the present proliferation of life writing and the various ways in which autobiographical texts present and explore subject constitution as relational. Specific topics include but are not limited to immigrant autobiography; slave narratives; Native American life writing; collaborative life writing; illness narratives; filial memoirs; politicians' and celebrities' life writing; blogs and social media.

Artforms and Artists in Videogames (Übung)

Artists are not necessarily the most common type of character to appear in videogames. Especially in blockbuster-games, masculine power-fantasies necessitate characters and gameplay that revolve around the military and the act of killing. However, there are games that specifically chose to include art or artist-like characters, be it through gameplay, as essential side-characters or even as the protagonist themselves. Therefore, this seminar will focus on and discuss various games that include art and artists in different forms. After an introduction to game studies in general and the analysis of videogames, we will discuss some elements of the Künstlerroman, their potential application to videogames and also provide an overview on artist characters in general. After this theoretical survey, we will dive right into the analysis of the videogames. Here, we will discuss how these games implement art and artists in their aesthetics, their stories and their gameplay. Each of them offers a

Canadian Fiction of the 20th and 21st Century (Übung)

Canada is often seen as a benign and benevolent country. Certain branches of Canadian literature seem to draw this into question. Therefore, in this course we will discuss texts focussing on minorities, both written by writers with a minority background and writers without it. Topics such as the treatment of immigrant workers, immigration but also the position of native Canadians within society, among other things, will be discussed. To facilitate this we will read two novels and short stories. In order to obtain credits you will have to write a thesis paper or do a moderation, as well as write an essay. Contemporary English Drama II (Vorlesung)

American Cultural History before the Civil War (Übung)

This course will offer an overview of key issues, trends, and events in early American cultural history. However, our focus will be on themes, discourses, and concepts rather than chronologies. Topics discussed will cover American identity constructions and value systems, ideas of God and nature, struggles over racism and slavery, the beginnings of the women's rights movement, experiments in alternative living, and developments in art and literature. Course requirements include a willingness to participate in classroom discussions and activities, as well as the punctual completion of both reading and writing assignments.

American Life Writing (Vorlesung)

Life writing, autobiography in particular, tends to focus on the life of one person, the autobiographer. However, as critics have highlighted in the past two decades, autobiographical texts do not only narrate and individual identity, but they tell stories of relationality: the individual's relation to other people (such as family) and to groups and collectives (such as an ethnic group or the nation). Such relationality plays a crucial role for narrative self-construction. This lecture course looks at the range of American life writing from the 1790s to the present proliferation of life writing and the various ways in which autobiographical texts present and explore subject constitution as relational. Specific topics include but are not limited to immigrant autobiography; slave narratives; Native American life writing; collaborative life writing; illness narratives; filial memoirs; politicians' and celebrities' life writing; blogs and social media.

It analyses media discourse as public discourse, institutional discourse and professional discourse, considering in particular the multi-layered nature of (1) its participation framework as regards production, reception, and audience design, and the construction of agency, identity, and newsworthiness, (2) its modes of transmission and multi-modality, including the private-public interface, and (3) the relationship between mass media and social media.</p> <p>Articulatory Phonetics (Übung)</p>

In this class you will be introduced to all the articulatory organs and processes involved in the production of speech starting from the brain "giving orders" to the muscles and including the lungs creating airflow, the larynx creating voice as well as the supraglottal articulators that create speech sounds that finally leave your lips as air pressure fluctuations. The class will examine all the speech sounds possible in human languages, but of course there will be a special focus on the speech sounds of English and the characteristics best used to describe them.

Basic Phonetics A (Übung)

This class offers an introduction to the principles of Phonetics and Phonology, including the articulatory basis and feature descriptions of especially the phonemes and allophones that occur in the major varieties of English. There will be a practical focus on both British (RP) and American (GA) standard pronunciations as well on phonological transcriptions both using IPA (an account of the organizational principles of the IPA will be provided as well) and, for students of the "Lehramt", the systems expected in the Bavarian state exams.

Basic Phonetics B (Übung)

Basics in Morphology and Word Formation (Übung)

In this course we will investigate in detail the internal structure of English words and the various processes that can be employed to enrich the lexicon by means of word-formation. After discussing the basic notions and key concepts in English morphology (e.g. word, word form, lexeme, morpheme etc.), we will take a closer look at various morphemic and non-morphemic word-formation patterns of present-day English (e.g. compounding, derivation, conversion, clipping etc.) from different perspectives. Whenever necessary, we will take a diachronic perspective and look, for instance, at the inflectional system or the productivity of certain word-formation patterns in different periods of English. There will be abundant opportunity to apply and practice morphological analyses in class.

Corpus Linguistics (Übung)

The ability to create, analyze and describe corpora is an absolute essential for proper linguistic research. In this course, you will acquire knowledge of the methodology of, and different approaches to, corpus analysis, learn how to use preexisting corpora, design and annotate your own and shape it for your intended research goals. To do that, we will cover a variety of tools and use them in a practical application approach, analyzing various linguistic features by gathering and processing data in a scientifically correct way, creating small corpora from different genres of discourse. While doing so, we will also look at challenges that arise when creating corpora, their qualitative and quantitative paradigms, statistical infrequencies and different plausibility functions as well as their implications on validity of data, and last but not least their use in fields such as language acquisition theory, diachronic linguistics and discourse analysis.

English as a Lingua Franca (Übung)

The English language can truly be called a "global language" as it is estimated that a quarter of the world's population is now able to communicate in English at a useful level. Furthermore, it is the most widely utilized language around the planet for international business, diplomacy, advanced education, law, the media, as well as for the dissemination of scientific and technological knowledge. A large proportion of those who use English are speakers of other languages, entailing a situation in which there are more non-native speakers than native speakers. As a result of this reality, in recent years a new approach to studying the use of English in international communication - English as a Lingua Franca (ELF) - has arisen. This course will explore issues related to ELF, including the features and characteristics of ELF use, the role of native speaker and standard language norms, language teaching and learning goals, linguistic stratification, and attitudes towards non-native speaker

Gricean Pragmatics and Beyond (Übung)

A (re)reading of some of the fundamental pragmatic theories will be accompanied by a discussion of possible problems, applications, and by empirical approaches to them. The ground covered will include Grice himself, Neo-Gricean pragmatics (e.g. Levinson, Horn), Relevance Theory (Sperber and Wilson), and politeness theory (e.g. Leech).

Institutional Discourse (Übung)

In this course, we will investigate discourse in a variety of institutional contexts (e.g. schools, courtrooms, universities, cooperations, clinics, hospitals). We will build up a general (practical) knowledge of conversational analysis (transcription, pattern recognition, case analyses) in order to probe the language in/of institutions with a particular emphasis on ideology and practice, discourse organization, collective identity as well as persuasion and manipulation. Case studies will include narratives in institutions; identity construction; 'talking an institution into being'; institutional gatekeeping encounters; front- and backstage in institutions; frame-shifting; facework and linguistic (im-)politeness; epistemic stance; language and power/agency and the interrelationships between professional and institutional discourses.

Modality (Übung)

How do we form and commit to predictions? How do we express the ability or necessity to do something? How do we know if an obligation is to be considered weak or strong? This course aims at providing answers to these questions (and more) by exploring form and function of modal expressions in different contexts: We will look at different sets of modals, quasi-modals and their adverb satellites and discuss their classification, strength, distribution as well as contextual use across various genres of spoken and written English. Whilst doing that, we will also examine differences and similarities of the various terminologies that are currently applied when modality is discussed and debate arising problems.

Quotations in Political Discourse (Übung)

Quotations are a ubiquitous meta-linguistic device; their communicative function consists in importing something said or written before into the discourse and assigning it the status of an object of talk. Through the act of quoting, the quoter expresses an evaluation of the source and/or content of the quotation, at the same time assigning the quotation the status of being relevant. The formatting of a quotation is chosen with regard to the contextual constraints and requirements of the discourse genre as well as to the quoter's communicative goal and intended perlocutionary effects. In this course, we are going to look at different forms of quotations and quotation markers, the functions of quoting, as well as various theoretical approaches to different aspects of quotation. We will focus on the strategic use of quotations in different types of mediated political discourse, such as interviews, parliamentary debates, commentaries, or editorials.

Syntactic Analysis (Übung)

This Übung provides a systematic and practically-oriented introduction to English syntax, the study of the internal structure of phrases, clauses and sentences. The aim of the course is to help students develop analytic skills to explore the patterns of English syntax, and learn precise ways of doing syntactic analysis for a variety of constructions. Based on Quirk et al.'s (1985) *Comprehensive Grammar of the English Language (CGEL)*, we will discuss various central topics (e.g. parts of speech, phrase structure, syntactic functions, coordination, subordination, multi-word verbs etc.), which will then be taken as a springboard for practical exercises. Sentences taken from the state exam will serve as the textual basis for a broad range of in-depth, problem-oriented syntactic analyses.

The Phonology-Morphology Interface (Übung)

In this seminar we will - as the title indicates - look at the interaction between phonology and morphology, starting with simple phonologically conditioned allomorphy like, e.g., the behavior of plural-/S/ and continuing with more complex processes like e.g., the well-known Trisyllabic Laxing Rule, which accounts for vowel changes like the one between 'divine' and 'divinity'. This will be our starting point for investigating of Lexical Phonology and Morphology as well as the accompanying phenomena of Cyclicity or the Elsewhere Condition.

21st-Century British Drama (Hauptseminar) The seminar will turn to major representatives of contemporary theatre and drama in England and Scotland. We will both have a look at major writers and a selection of plays and also turn to the extremely versatile aesthetics of these plays. Theoretical perspectives include questions of the philosophy of drama as well as performance studies and issues of audience interaction and spectatorship. Plays to be discussed are: David Greig, The Events; debbie tucker green, hang Caryl Churchill, Love and Information Duncan Macmillan, Every Brilliant Thing Alice Birch, Revolt. She Said. Revolt Again. These playtexts will be made available as uploads.		
Aktuelle Fragen der Literaturtheorie tba		
James Joyce and the Modernist Novel II (Hauptseminar) James Joyce, who was born in Dublin in 1882 and who died in Zurich in 1941, is certainly the most innovative and path-breaking novelist of the twentieth century worldwide. Joyce's fiction and his experimental prose are epitomes of the modernist movement and a new, fragmented, and psychologically modernist, that is, inward and phenomenological view of life. Stream-of-consciousness techniques, which had their origin in late-19th century movements such as naturalism and literary impressionism, were brought to perfection in Joyce's works. The seminar will elaborate on major characteristics of the modernist and avantgarde movements in the 20th century.		

The seminar will, then, turn to Joyce's fiction in a chronological order: After starting with the short story collection *Dubliners* last semester, we shall move on to his famous (autobiographical) novel *A Portrait of the Artist as a Young Man* and his modernist masterpiece *Ulysses*. Textual work in the seminar will be based on the following edit ... (weiter siehe Digicampus)

Spaces & Places in Romanticism (Hauptseminar)

The (re-)construction of spaces/places is a major topic in Romantic literature. These depictions involve, for example, (lost) natural spaces, cities, sublime spaces, graveyards or ruins. In this seminar, we will explore Romantic appropriation of spaces/places by scrutinizing their socio-historical and cultural embeddedness, and by analyzing their aesthetic structures. For this purpose, we will, firstly, approach the concepts of space/place theoretically (e.g. Michel de Certeau or Michail Bachtin) and then analyze a wide selection of Romantic texts from various critical angles. A reader with selected (primary and secondary) texts will be made available at the beginning of term.

Testimonios and Testimonial Narrative in Chicana and Latina Literature (Hauptseminar)

Testimonio as a literary genre originated in Latin America and usually tells a story in a collective mode, or offers an individual's story as representative of a people and, more specifically, a community. In this course, we consider both the literary, visual, and performative versions of testimonio in order to investigate how individual experiences can represent a group and resonate powerfully beyond geopolitical and cultural borders. Moreover, this course explores the notion of testimony as an important aspect of a literature of resistance. We will explore how testimonio intertwines with questions of writing and truth, and how these expressions form an attempt to posit a literature of testimony as an ethical response to cultural violence. This course will examine the theories and literature of resistance and testimonio in a wide-ranging selection of time periods and cultures, with a focus on the Chicana/o Movement of the late-1960s and 1970s. Theories and Methods in Literary Studies

This class introduces MA students to some of the main theoretical frameworks applied in literary and cultural studies. While thus providing an overview, its central focus is on the close critical engagement with theoretical texts. The supplementary 'Übung' will offer the opportunity to apply these frameworks to the reading of literary and other cultural texts but also to reflect on the critical challenges such texts at times present to theory. A reader of all relevant texts will be available at the American studies office at the beginning of the semester.

Time and Literature (Hauptseminar)

Time is the fundamental (ontological) condition of our lifeworld. According to Martin Heidegger, it is our own limited temporality (*Sein zum Tode*) which makes our life meaningful in the first place. This seminar will turn to literary (re-)constructions of time together with their aesthetic and historical-cultural contexts. For this purpose, we will, firstly, approach the notion of time theoretically and then analyze a wide selection of literary texts and genres (ranging from the early modern period to the 21st century) from various critical angles. A detailed reading list and a reader with selected (primary and secondary) texts will be made available at the beginning of term.

Writing America in the 21st Century - Contemporary American Short Stories (Hauptseminar)

The development of the American short story genre was a national phenomenon with considerable success. Ranging from supernatural and fantastic elements to realist or naturalist descriptions of local cultures and (post)modern narratology, the American short story offers fruitful approaches for the studies of American cultural life, society and public discourses. In this seminar we will read, analyze and contextualize contemporary American short stories which were published this year. We will investigate the genre of the short story and its most recent developments and topics. The seminar will be offered as a block seminar taking place in the new year with an obligatory first session in November. Participants need to obtain the edition of "Best American Short Stories 2018" from Mariner Books (available from October 2018) before the November session! ... (weiter siehe Digicampus)

Writing New York from the 1880s to the 1920s

The diversity and dynamics of cities have long capture the cultural and literary imagination. While Paris has been seen by many critics as paradigmatic for the world cities of the 19th century, New York has taken over that role for the 20th, and this strongly reflects in literary and other cultural texts. This seminar will focus on a time period

of particularly accelerated New York development from the 1880s to the 1920s and explore the multifariousness of urban representation in literary texts, photography, and social criticism. Central for our inquiry will be how the increasing diversification of urban life worlds (e.g. through immigration, industrialization etc.) is represented and critically negotiated. Please get a copy of John Dos Passos' novel Manhattan Transfer (1925). Additional texts will be available on digicampus at the beginning of the semester. The seminar is supplemented by a 'Übung' on Urban Literary Studies. Please note that the 'Übung' is mandatory for students who ta

American Cultural History before the Civil War (Übung)

This course will offer an overview of key issues, trends, and events in early American cultural history. Starting out with a look at Pre-Columbian civilizations, we will then work our way from the colonial period to the revolutionary era and on into the 19th century. However, our focus will be on themes, discourses, and concepts rather than chronologies. Topics discussed will cover American identity constructions and value systems, ideas of God and nature, struggles over racism and slavery, the beginnings of the women's rights movement, experiments in alternative living, and developments in art and literature. Course requirements include a willingness to participate in classroom discussions and activities, as well as the punctual completion of both reading and writing assignments.

American Life Writing (Vorlesung)

Life writing, autobiography in particular, tends to focus on the life of one person, the autobiographer. However, as critics have highlighted in the past two decades, autobiographical texts do not only narrate and individual identity, but they tell stories of relationality: the individual's relation to other people (such as family) and to groups and collectives (such as an ethnic group or the nation). Such relationality plays a crucial role for narrative self-construction. This lecture course looks at the range of American life writing from the 1790s to the present proliferation of life writing and the various ways in which autobiographical texts present and explore subject constitution as relational. Specific topics include but are not limited to immigrant autobiography; slave narratives; Native American life writing; collaborative life writing; illness narratives; filial memoirs; politicians' and celebrities' life writing; blogs and social media.

Artforms and Artists in Videogames (Übung)

Artists are not necessarily the most common type of character to appear in videogames. Especially in blockbuster-games, masculine power-fantasies necessitate characters and gameplay that revolve around the military and the act of killing. However, there are games that specifically chose to include art or artist-like characters, be it through gameplay, as essential side-characters or even as the protagonist themselves. Therefore, this seminar will focus on and discuss various games that include art and artists in different forms. After an introduction to game studies in general and the analysis of videogames, we will discuss some elements of the Künstlerroman, their potential application to videogames and also provide an overview on artist characters in general. After this theoretical survey, we will dive right into the analysis of the videogames. Here, we will discuss how these games implement art and artists in their aesthetics, their stories and their gameplay. Each of them offers a

Canadian Fiction of the 20th and 21st Century (Übung)

Canada is often seen as a benign and benevolent country. Certain branches of Canadian literature seem to draw this into question. Therefore, in this course we will discuss texts focussing on minorities, both written by writers with a minority background and writers without it. Topics such as the treatment of immigrant workers, immigration but also the position of native Canadians within society, among other things, will be discussed. To facilitate this we will read two novels and short stories. In order to obtain credits you will have to write a thesis paper or do a moderation, as well as write an essay. Participation, regular attendance, and reading the texts are mandatory. Please purchase a copy of Sky Lee's *Disappearing Moon Café* as well as Eden Robinson's *Monkey Beach*. Contemporary English Drama II (Vorlesung)

Die Vorlesung wird sich der wichtigsten Vertreterinnen und Vertreter des Neuen Englischen Dramas annehmen, das seit dem Skandalerfolg von John Osbornes *Look Back in Anger* aus dem Jahre 1956 zu einem der wichtigsten, innovativsten und lebendigsten Strömungen dramatischer Weltliteratur avanciert ist. Es werden historische Aspekte des englischen Theatersystems diskutiert wie, zum Beispiel die Konzeption eines National Theatres. Darüber hinaus wird perspektivisch das englische Drama im 20. Jahrhundert nicht nur am viktorianischen Erbe, am Modernismus, am Versdrama und am Well-Made-Play gemessen, sondern auch zu den zentralen pan-europäischen Entwicklungslinien des Dramas (episches Theater, absurdes Theater, Metadrama) in Beziehung gesetzt, zu denen es in einer kreativen Wechselbeziehung steht. Drama Analysis (Übung)

This course provides students with the basic skills needed for analysing drama. We will discuss and apply the most essential concepts of drama analysis, from ancient and early modern theories of tragedy and the distinction between absolute and epic drama to methods of figure characterisation, the categories of time and space, and contemporary discussions concerning the relation between text and performance. We will work with one full-length play (J. B. Priestley's "*An Inspector Calls*") and excerpts from various plays from different historical periods and of different genres which will be made available on Digicampus. Drama Analysis is one of the five major areas relevant to literary studies (prose, drama, poetry, film, and literary theory) and is offered once every year.

Drama Analysis (Übung)

This Übung will acquaint students with the basic skills needed for the analysis of dramatic texts. By looking at two full-length plays and some further excerpts as well as influential theoretical backgrounds, students will gain insight into all essential elements of drama analysis. We will discuss and apply aspects of structure and dramatic speech as well as concepts of time, space and characterization. By examining a variety of different American plays, we will explore the genre as a whole, but also distinguish between categories of epic and absolute drama. Students will need to acquire two plays (tba), additional material will be made available in a reader at the beginning of the semester. Students attending the seminar "Environmental Disaster Narratives and Plays" within the module EAS-1411 will automatically be allotted to the Übung "Drama Analysis" (Milena Krischer, Tuesdays 8.15 – 9.45 a.m.) or "Narrative Analysis" (N.N., Thursdays 3.45 - 5.15 p.m.).

Introduction to the Environmental Humanities (Übung)

Environmental issues are among the most pressing concerns of our time. Can the humanities help in understanding and mitigating them? Yes, in significant ways, experts are coming to realize. Of course, exploring the history of an idea, analyzing communication practices, or studying how societies and cultures are organized cannot, by itself, stop climate change or put an end to species extinction, but neither can measuring greenhouse gases, or researching the hormonal effects of pesticides. As environmental problems result from interacting natural and cultural processes, dealing with those problems requires both scientific and humanistic knowledge and, beyond that, integrative thinking across and outside disciplinary and epistemological boundaries. This kind of thinking is precisely what the emerging field of the Environmental Humanities attempts to promote. Combining the methods and perspectives of a wide range of subjects from the humanities and social sciences (including cultural stud

Narrative Analysis (Übung)

Ziel dieser Veranstaltung ist die Auseinandersetzung mit zentralen Konzepten und Kategorien der Erzähltheorie. Neben Autor, Erzähler und Leser gehören dazu z.B. auch die Wahl der Perspektive, Gestaltungsmöglichkeiten bei der Darstellung von Innenwelten oder die Handhabung von Zeit und Raum. Narrative Analysis (Übung)

This course aims at introducing and applying central concepts and categories of narrative theory. Key areas are: - The tripartite model of author, narrator and reader - narrative point of view - strategies of rendering consciousness - narrative (re-)constructions of time and space - unreliable narration Our study of these categories will be accompanied by and advanced in classroom based analyses of selected narrative texts. A reader with selected (primary and secondary) texts will be made available at the beginning of term. Narrative Analysis is one of the five major areas relevant to literary studies (prose, drama, poetry, film, and literary theory) and is offered once every year. Students are advised to have attended all analysis courses before registering for their final exams.

Poetry Analysis (Übung)

This course aims at providing students with the tools needed for the successful literary analysis and interpretation of a poem. Looking at a wide range of poems from the Renaissance to the present, we will have ample opportunities to practise both the basic skills of poetry analysis (identifying the metre, stylistic devices etc.) and how to integrate these technical analyses into the interpretation of a poem. Furthermore, students will get an overview of the most common poetic genres (such as sonnet, ode, ballad, dramatic monologue, ...) as well as of the history of poetry in the British Isles since the Renaissance. Poetry analysis is one of the five major areas relevant to literary studies (narrative, drama, poetry, film and literary theory). This course is intended for all students of English and American Studies, who should attend courses in all five of these areas before they register for their final exams. Survey of English Literature III: Romantic Period and Victorian Age (Übung)

This survey course is the third of a four-part series covering English literary history from the Middle Ages to the present. This term we will focus on English literature from the late 18th century to the 19th century, and thus include the Romantic period and the Victorian Age. In this course, participants are expected to read a wide range of textual samples and examples by relevant authors. A reader with assorted texts will be made available at the beginning of term. Besides that, students are required to obtain their own copies of the following texts: • Mary

Shelley, *Frankenstein* (1818 text; Penguin Classics) • Charlotte Brontë, *Jane Eyre* • Charles Dickens, *Hard Times* (Penguin Classics) It is highly advisable to read at least one of these before the beginning of term in order to alleviate the reading load during the semester.

Theatre Trip to London 2019 (Übung)

Termin: voraussichtlich Mitte März 2019 Die Exkursion führt Studierende/Theaterinteressierte aus Augsburg in sämtliche Bereiche der englischen Theaterzene ein: National Theatre, das experimentelle Royal Court Theatre (English Stage Company) und kleinere Bühnen werden ebenso besucht wie die Royal Shakespeare Company in Stratford-upon-Avon, das ebenso wie Oxford (Magdalen-College, Ashmolean Museum) im Rahmen ein Ziel einer Tagesfahrt sein wird. Urban Literary Studies (Übung)

This Übung supplements the seminar "Writing New York from the 1880s to the 1920s". We will engage more systematically with theoretical questions pertaining to the link between urban studies and literary representations of New York City. Please get a copy of Henry James' novel *Washington Square* (1881). A reader with additional texts will be available at the beginning of the semester.

Ü Cultural Analysis (Übung)

Based on an introduction to key concepts of cultural studies, this hands-on course teaches students essential skills to critically analyze culture. Focusing on cultural phenomena and current debates relating to concepts such as identity, nationalism, 'race', class, and gender, we will discuss how normative conceptualizations of these terms can be challenged and scrutinize the ways in which power manifests itself in representations.

Ü Film Analysis: Indigenous Film (Übung)

This course is an introduction to the analysis of films. The focus is primarily on practical approaches. After short methodical introductions in each session, we will actively use the key concepts of film analysis in in-class exercises, group and plenum discussions and peer reviews of response paragraphs.
